Claims Submission Procedure – Insulin Pump Supplies

Effective January 24, 2023

Please include this Procedure in your Drug Programs Information Network (DPIN) Manual under Section 4: Claims Submission.

- Effective **January 24, 2023**, new product specific PINs must be used when submitting claims for insulin pump supplies to DPIN and the following quantity limits are in place:

Product Type	Approved Quantity
Infusion set / Infusion kit (including cannula and tubing)	240 sets / kits per benefit year (or 480 total pieces per benefit year)
Reservoir / Cartridge / Pod	240 per benefit year
Serter / Inserter	1 per benefit year

- The PIN entered for a claim must be specific to the product being dispensed. The new insulin pump supplies PINs are listed on page 2.
- For all claims, the quantity submitted should reflect the **total number of pieces** within a set / kit / box. For example:
 - If dispensing 1 kit that contains 1 cannula and 1 tubing, total quantity = 2
 - If dispensing 1 kit that contains 10 cannula and 10 tubing, total quantity = 20
 - If dispensing 2 kits, each containing 10 cannula and 10 tubing, total quantity = 40 ((10 + 10) X 2)
 - If dispensing 1 box of pods containing 10 pods, total quantity = 10
- The old insulin pump supplies PINs 905739, 908300, 908320, 992976, 992984, and 992991 will no longer be eligible benefits effective January 24, 2023.
- If a pharmacy plans to order / dispense insulin pump supplies that are **NOT** among those listed on page 2, please contact the DPIN Help Desk (204-786-8000 or 1-800-663-7774, Option 2) prior to placing an order. The Pharmacy will be required to provide client Personal Health Identification Number (PHIN) and manufacturer details before eligibility can be confirmed.
