Pursuant to sub-rule 28(1), Hon. Min. MARCELINO, Ms. BYRAM, Hon. Mr. BUSHIE, Mr. KHAN and Hon. Mr. KOSTYSHYN made Member's statements.

The following petitions were presented and read to the Legislative Assembly of Manitoba:

- Mrs. HIEBERT To urge the Provincial Government to assist the City of Winnipeg to address serious safety risks for all that frequent the FWA area by twinning and installing a traffic light and crosswalk at the intersection of McGillivray Boulevard and Brady Road, as is it transitions into Provincial Trunk Highway 3.
- Mr. WOWCHUK To urge the Provincial Government to call on the Federal Government to remove the punishing carbon tax on natural gas and other fuels and farm inputs for Manitoba agriculture producers and the Agri-food sector to decrease the costs of putting food on the table for Manitoba consumers.

Mr. JACKSON – To urge the Premier and Minister of Transportation and Infrastructure to immediately prioritize the reconstruction of Provincial Trunk Highway 2 in the upcoming construction season; and to urge the Provincial Government to include the stretch of Provincial Trunk Highway 2 that runs through the Town of Souris in its reconstruction plans.

Mrs. Stone – To urge the Provincial Government to lobby the Federal Government to stop the expansion of medical assistance in dying to those for whom mental illness is the sole condition; and to lobby the Federal Government to protect Canadians struggling with mental illness by facilitating treatment, recovery, and medical assistance in living, not death.

The House resumed the debate on the proposed motion of Hon. Mr. WIEBE:

THAT Bill (No. 30) – The Unexplained Wealth Act (Criminal Property Forfeiture Act and Corporations Act Amended)/Loi sur les richesses inexpliquées (modification de la Loi sur la confiscation de biens obtenus ou utilisés criminellement et de la Loi sur les corporations), be now read a Second Time and be referred to a Committee of this House.

And on the proposed amendment of Mr. JOHNSON as follows:

THAT the motion be amended by deleting all the words after the word "THAT" and substituting the following:

this House declines to give Second Reading to Bill (No. 30) – The Unexplained Wealth Act (Criminal Property Forfeiture Act and Corporations Act Amended)/Loi sur les richesses inexpliquées (modification de la Loi sur la confiscation de biens obtenus ou utilisés criminellement et de la Loi sur les corporations), because this House has not received satisfactory evidence or assurance that this Bill is different to the existing legislation that was brought forward and passed in this House in 2021.

And the debate continuing on the amendment,

And Messrs. NESBITT and KING and Mrs. STONE having spoken,

And Mr. WHARTON speaking at 5:00 p.m. The debate was allowed to remain in their name.

The House then adjourned at 5:00 p.m. until 10:00 a.m. Tuesday, May 14, 2024.
